

# Eligibility for MBA FY Admission 2026-27

## 1. Educational Qualifications

- **Minimum Marks:** General category candidates must have at least **50%** aggregate marks (or equivalent CGPA) in their Bachelor's degree from a UGC-recognized university. Reserved categories (SC, ST, VJ/DT-NT, OBC, SBC, PWD, and EWS) belonging to Maharashtra State only have a relaxed minimum of **45%** marks.
- **Final Year Students:** Candidates in their final year of a bachelor's degree can also apply, provided they submit their passing degree proof by the institutional counseling/admission deadline.
- **Age Limit:** There is no maximum age limit for MAH MBA CET or most Maharashtra MBA programs.

## 2. Entrance Exam Requirements

- **MAH MBA CET Route:** Applicants appearing for the state-level MAH CET-2026 must obtain a valid, non-zero score.
- **All India/National Exams:** Candidates with valid scores in national exams like the CAT, CMAT, XAT, MAT, ATMA, or GMAT – 2026 are also eligible for admission to All India quota seats.

## 3. Candidate Candidature Types

- **Maharashtra State (MS) Candidates:** Must hold a domicile certificate of Maharashtra or have completed qualifying education within the state. They are eligible for reserved category seats and state counseling.
- **All India (AI) Candidates:** Indian nationals from outside Maharashtra can apply and use national exam scores to participate in the Centralized Admission Process (CAP).

## DOCUMENTS REQUIRED:

Keep the following specific documents ready (in original along with scanned copies) for the State CET Cell's CAP (Centralized Admission Process) in 2026:

### 1. Personal & Identification Documents

- **Aadhaar Card:** Ensure your Name and Date of Birth match exactly with your Class 10th certificate.
- **APAAR ID:** Required for Digilocker authentication and profile entry during CET registration.
- **Digilocker Credentials:** 6-digit security PIN for data fetching.
- **Passport-Size Photograph:** Scanned color photo with a white background, full face, covering 80% of the area, and sized between 100 KB and 5 MB.
- **Scanned Signature:** Sized between 50 KB and 5 MB.

### 2. Academic Records (Mark Sheets & Certificates)

- **Class 10 (SSC) Mark Sheet & Passing Certificate:** For verification of Date of Birth.
- **Class 12 (HSC) / Diploma Mark Sheet:** For board name, passing year, and percentages.
- **Graduation Degree & Mark Sheets:** All semester mark sheets and the degree/provisional certificate.

### 3. State & Domicile Eligibility

- **Domicile Certificate:** Mandatory for Maharashtra State (MS) candidates to claim home-state quota and specific state reservations.
- **Birth Certificate / Leaving Certificate:** If Domicile is unavailable, these can act as proof of birthplace in Maharashtra.

### 4. Category & Caste Certificates (If Applicable)

- **Caste Certificate:** Issued by the competent authority in Maharashtra.
- **Caste Validity Certificate:** Mandatory for reserved category candidates (e.g., SC, ST, VJ/DT, NT, OBC, SBC).
- **Non-Creamy Layer Certificate:** Required for OBC, VJ/DT, NT, and SBC categories. Ensure it remains valid as per state guidelines.
- **EWS Certificate:** For Economically Weaker Section candidates.

### 5. Other Special Certificates

- **PwD Disability Certificate:** Issued by the competent medical board, along with your UDID card.
- **Entrance Exam Scorecard:** Scorecard of the entrance exam you are using for admission (MAH MBA CET, CAT, CMAT, XAT, etc.)
